1. Entry can only be made online. Full instructions are enclosed. The closing date for entry is now **Friday 10**th **May**, **2024**.

2. ENTRY REGULATIONS:

- (a) Each school may enter two Relay teams per age group. At this stage schools only need to tick the appropriate box if they wish to enter a Relay team. Names and dates of birth will be asked for on the day of the Championships. If you do not have four runners in an age group then schools may run ONE competitor per Relay from the age group below (except in 400m and 800m relays). This year there will again be a Girls 4 x 400m event and a Boys 4 x 400m event. In addition, there will also be a Girls 3 x 800m event and a Boys 3 x 800m event. Like the 4 x 400m events, these two events will be Over 15, ie a combined team from groups A & B. Athletes may obviously only compete in ONE Relay.
- (b) Entry fees for each Relay team are £20:00. Please make cheques payable to "The Scottish Schools' Athletics Association" or "SSAA" and send, together with the enclosed form, to Pete Russell, NO LATER THAN 19th MAY.

- (c) All competing schools are asked to provide a member of staff who is willing to officiate see separate form. All schools must name the accompanying adult who <u>WILL BE ASKED TO</u> <u>OFFICIATE IF NECESSARY.</u>

Pupils must be in Secondary school.

- 6. Anti-Doping

All entrants shall be deemed to have made themselves familiar with and agree to be bound by the UKA Anti-Doping Rules and to submit to the authority of UK Anti-Doping in the application and enforcement of the Anti-Doping Rules.
